FROM THE CEO/GENERAL MANAGER

2023 CEO Report

Please accept our invitation to attend the 86th Annual Meeting of The Sedgwick County Electric Cooperative Association, Inc. The meeting and meal are free for co-op members and will be held Tuesday, April 9, 2024, at The Cotillion in Wichita. Registration will begin at 6:15 p.m. and dinner will be served at 6:30 p.m. Our formal meeting will be short, and there will be plenty of door

prizes given away along with \$10 bill credits for those attending.

Your co-op completed 2023 in good financial standing and looks forward to serving your energy needs for many years to come. Your co-op finished 2023 with margins totaling \$1,732,977. This was below the \$2,006,858 margins in 2022, but enough to meet our mortgage requirements. This favorable financial position allowed the board of directors to approve the general retirement of 100% of the capital credits from the 2006 PATRONAGE TOTALING APPROXIMATELY \$551,326. This is an increase in patronage of over \$100,072 from 2022. These capital credits were applied to your March electricity bill. We attribute this strong financial position to a supportive board of directors, committed and talented staff and loyal financial/business partners. We are blessed and privileged to serve you, our member-owners. As a member-owned co-op, Sedgwick County Electric Cooperative is committed to providing safe, reliable, innovative energy solutions for you, our member-owners.

Quality service to our members starts with the very infrastructure that carries electricity to the homes, farms and businesses vital to the success of our communities. Upgrading and maintaining infrastructure is important to the reliability of the system. Our current comprehensive construction work plan calls for more than \$8 million in infrastructure upgrades in the next five years. Upgrades include increasing the capacity of existing overhead and underground distribution lines, constructing new lines in areas with accelerated growth, and replacing older distribution poles and aging overhead and underground conductor.

YOU'RE A CO-OP MEMBER-OWNER

Being part of an electric cooperative is unique. Why? Because cooperatives are not typical businesses. There are more than 900 electric co-ops in the U.S., and each is slightly different because they are designed to serve the needs of the local community. Sedgwick County Electric was formed as a non-profit in 1937 by farmers and ranchers to serve the community. More than 85 years later we are still committed to serving and improving the communities we power.

Upgrading our advanced metering infrastructure (AMI) will allow integration with an outage management system (OMS), resulting in faster and more efficient outage detection and diagnosis. This system provides detailed reports on the type and potential cause of the outage, giving line crews an idea of what to expect.

The increased reliability and financial condition of our coop are due in a large part to the dedication and hard work of the employees and management of Sedgwick County Electric Cooperative. On behalf of myself and the entire Sedgwick County Electric Board of Directors, I would like to thank all the employees and the members of Sedgwick County Electric Cooperative for your support and commitment to making our co-op one we can all be proud of.

While continuing our commitment to improved reliability, your co-op board and management remain committed to maintaining reasonable rates. We continually scrutinize our co-op operations to hold the line on costs, while closely monitoring issues and legislation at both the state and national levels that could adversely affect our ability to keep costs low for our members.

We continue to deal with the effects of inflation, fuel prices and supply chain issues. Sedgwick County Electric's cost to provide service has increased as a result. Materials to construct and maintain our infrastructure, repair our service vehicles, and run our daily operations come with much higher price tags and significantly longer lead times. In some cases prices have doubled, and we are seeing lead times in excess of one year. We continue to work with our suppliers to manage our inventory and ensure we use all resources to contain costs.

I would also like to thank you, our members, for your ongoing

support in the past year. Your support through letters, emails, social media posts and calls are appreciated by the employees who worked hard to bring you the best service possible. Co-op members — our member-owners are the key to our success.



85th Annual Meeting Minutes

The 85th Annual Meeting of The Sedgwick County Electric Cooperative Association, Inc. was held at The Cotillion in Wichita, Kansas, on April 4, 2023. President Clint DeVore called the meeting to order at 7:02 p.m. Father Birket gave the invocation and President DeVore welcomed the directors. members and special guests.

There were 265 members registered (50 members constitute a quorum). A meal was served to 450 guests prior to the official meeting.

President DeVore recognized the men and women in the armed forces and first responders. He also introduced the Sedgwick County Electric Cooperative Board of Directors, General Counsel Greg Lee and General Manager/CEO Scott Ayres.

President DeVore reported that the Secretary had in her possession the official notice and proof of mailing of the notice. It was moved and seconded that these documents be accepted and omit reading. Motion carried.

President DeVore requested that the minutes of the 84th Annual Meeting be approved as printed in the notice and omit reading. A motion was made and seconded to omit reading and accept the 84th Annual Meeting minutes as printed in the notice. Motion carried.

Manager Ayres highlighted in his overview of the financial report the cooperative completed the year 2022 in a good financial position. He stated that 100% of capital credits from 2005 were returned to the membership, and that margins are adequate to meet the financial requirements of our lenders. He stated we have maintained some of the most competitive rates for

electric co-ops in Kansas, finishing the year with equity of 58%, and have a good financial position to fund our construction, maintenance and operational needs. He noted how much the industry has changed in the last five years with electric technology moving at an incredible pace (electric vehicles, EV charging, solar, battery storage and wind renewables).

Manager Ayres called on General Counsel Lee to read the names of those running for the position of director as follows: Territory 1 — Cindy Foster, Territory 2 — Alan Smarsh, and Territory 3 — Rex Smith. General Counsel Lee asked if any candidate would like to address the membership prior to the casting of ballots. Candidates declined to speak. General Counsel Lee addressed the rules of voting per the bylaws of the cooperative. Votes were cast by the membership and ballots were collected by the employees. The assigned tellers and employees were called upon to tally the ballots.

Manager Ayres announced the 2023 youth program winners. LEVI SELF of Cheney High School, son of Travis and Erin Self. will attend the Electric Cooperative Youth Tour to Washington, D.C., and receive a \$500 scholarship. MESA BRADBURY of Andale High School, daughter of Harvey and Megan Bradbury, will attend the Cooperative Youth Leadership Camp near Steamboat Springs, Colorado, and receive a \$500 scholarship. New this year, Sedgwick County Electric awarded two additional \$500 scholarships to **CHLOE YOUNG** of Cheney High School, daughter of Chad and Brooke Young,

and LANDON KROUPA of Bishop Carroll High School, son of Cory and Allison Kroupa.

Manager Ayres called upon the 2022 youth program winners Amelia Meng and Micah Goodman to speak about their cooperative sponsored trips.

Manager Ayres called upon General Counsel Lee to announce the director election results. Those elected for a three-year term were: Territory 1 — **CINDY FOSTER**; Territory 2 — **ALAN SMARSH**; and Territory 3 — **REX SMITH.**

President DeVore asked if there was any unfinished business; there was none. He then called for any new business. There being no new business, President DeVore declared the 85th Annual Meeting officially adjourned at 7:41 p.m.

Manager Ayres thanked all those who had taken time to attend the annual meeting. He distributed years of service recognition gifts to the employees and directors and thanked them for their service to the cooperative: Line Superintendent Kyle Pipkin for 25 years; Office Manager Lora Alloway and Foreman Andy Riggs both for 20 years; Accountant Jacque Matchett for 10 years; Apprentice Lineman Victor Ayala for 5 years; and Director Margie Conyac and Director Alan Smarsh both for 15 years. He shared that this past year our employees achieved two safety awards - No Lost Time and Certificate of Achievement for Safety — and thanked the employees for working together safely. He introduced the employees, then began the drawing for prizes.



QUORUM NEEDED. Under Article III, Section 3.04 of the bylaws of Sedgwick County Electric Cooperative, a meeting can be held if 50 members are present. Be sure to attend so business can be conducted.

YOUR MEMBERSHIP is on record with the cooperative as this notice has been addressed. According to bylaw provisions, only members can register.

REGISTRATION will begin at 6:15 p.m. Dinner will be served at 6:30 p.m.

SPECIAL NOTE Acting under Article IV, Section 4.02 of the bylaws which reads: "Members of the Board of Directors shall be elected by the members of the Cooperative from nine (9) Director Territories and shall serve for a term of three (3) years, or until their successors shall have been elected. The Cooperative shall stagger Director Terms by dividing the total number of authorized Directors into groups of three (3) and Members must annually elect three (3) Directors. The Cooperative members shall elect Directors by a plurality of the votes cast, and the Cooperative members may not vote for write-in candidates, by proxy, and there shall be no nominations from the floor at the Annual Meeting. Members of the Board of Directors shall be elected by ballot and from the members of the Cooperative. The individual presiding at the annual meeting shall announce the results of the election."

CAPITAL CREDIT REFUNDS totaling approximately \$551,326 have been distributed to members who received service from the cooperative in 2006.

ATTENDANCE PRIZES will be drawn at the close of the business meeting. YOU MUST BE PRESENT AT THE TIME OF THE DRAWING TO WIN.
